Rules for Endorsement

- 1. Eligibility.** To be considered for endorsement, a candidate must have been a member of the Party as of the deadline for filing nomination papers for the election for which endorsement is sought. The candidate must also notify the Vice-Chair of Campaigns not later than the filing deadline that he/she wishes to be considered for endorsement.
- 2. Endorsement Vote.** To receive the County Party endorsement, a 2/3 vote is required.
- 3. Benefit.** No candidate will receive a contribution from the County Party unless that candidate is endorsed.
- 4. Dual Endorsement.** In the case of a dual endorsement, no contribution will be made.
- 5. Primaries.** Where 2 or more Democrats are running in a primary, no endorsement will be made.
- 6. Other Parties.** An endorsement by the County Party of, or a contribution by the County Party to, a candidate for one or both of the elections in an election cycle shall not be made unless the candidate confirms that he or she has not solicited or received and agrees not to solicit or willingly receive an endorsement of any other political party for any election in the same election cycle. "Other political party" means any unit of any political party other than the Democratic Party of Dane County, Wisconsin, or the United States.
- 7. Suspension.** A standing rule on endorsements may be suspended by a 2/3 vote at a meeting at which endorsements are to be voted on.

Rules for Endorsement

1. **Eligibility.** To be considered for endorsement, a candidate must have been a member of the Party as of the deadline for filing nomination papers for the election for which endorsement is sought. 2. **Endorsement Vote.** ~~To receive the County Party endorsement, a 2/3 vote is required.~~ To receive the County Party endorsement, a candidate must interview with the Campaigns Committee. A candidate must then receive a 2/3 vote for endorsement recommendation from the Campaigns Committee. Campaigns Committee recommendations must receive a majority vote at a County Party meeting in order for a candidate to receive an official party endorsement.
3. **Benefit.** No candidate will receive a contribution from the County Party unless that candidate is endorsed.
4. **Dual Endorsement.** In the case of a dual endorsement, no contribution will be made.
5. **Primaries.** Where 2 or more Democrats are running in a primary, no endorsement will be made.
